

1. NOTICE OF MOTION IN THE NAME OF COUNCILLOR VIRGINIA O'DOWD

"I am calling on Nenagh Town Council to work in conjunction with North Tipperary County Council and Nenagh Chamber of Commerce to appoint a marketing officer for North Tipperary who will work alongside the Tourism Officer and the Tourism Forum to promote and market tourism in North Tipperary".
